## Instructions

Every music licensing association or corporation (agency) that licenses the public performance of nondramatic musical works in this state on behalf of copyright owners is required to be registered beginning January 1, 2019. The registration application must be submitted on or before February 15 of the registration year. This registration is required to be renewed annually. If an agency licenses or attempts to license the sale, license, or other disposition of the public performance of copyrighted nondramatic musical works in this state without registering, or fails to renew the registration, a fine in the amount of \$10,000 will be imposed for each 45 day period which has passed since February 15 of the registration year.

**Line 10**. In conjunction with this registration application, the music licensing agency must submit the following information and documentation:

- a. The agency's web address (URL) that contains the current list of the performed works that your agency licenses,
- b. The agency's web address (URL) that contains the list of all of the agency's members and affiliates represented by your agency, and
- c. An electronic copy of each variation of the performing-rights agreement providing for the payment of royalties made available from the music licensing agency to any proprietor within this state. The electronic copy of the different agreements must be submitted on a mobile storage device, for example a CD, DVD, flash or thumb drive.

For additional information regarding the Music Licensing Agency Act, please review Neb. Rev. Stat. §§ 59-1401 to 59-1406.

**Line 11.** An authorized contact person designated on line 11 will have the authority to receive the Nebraska ID number assigned from this application.

**Signatures**. This registration application submitted to the Department must be signed by the owner, partner, member, or corporate officer. If another person signs this application, there must be a <u>Power of Attorney</u>, <u>Form 33</u> attached to this application.
