Instructions

Who Must File. Every person applying for a Stamping Agent's License and every common carrier applying for a permit to transport unstamped cigarettes is required to file a bond. Every stamping agent or common carrier must maintain a current bond while the license or permit remains active.

When and Where to File. The bond must be attached to your initial Nebraska Cigarette and Tobacco Products License and Registration Application, Form 20CT. The bond and application must be mailed to the Nebraska Department of Revenue, PO Box 98903, Lincoln, NE 68509-8903. If a bond or application is received separately, it will be returned to the applicant.

Determination of Amount. The minimum acceptable bond amount is \$10,000 for each Stamping Agent's License or \$1,000 for each Common Carrier Permit to Transport Unstamped Cigarettes. Failing to maintain a proper bond is cause for license or permit suspension or cancellation.
